1. Call to Order

3. Welcome of New Members

Jackie welcomed new members, Carol Cooper and Frank Fowler, to the Heritage Commission and Cynthia Anonuevo as the new recording secretary (City Staff support).

5. Old Business

- a) Congratulatory letters sent by Jackie, who indicated that there was Newspaper coverage on the Bodega Hotel and will file the article.
- b) New Walking Tour Brochures are available through Tourism Rossland.

 Bob Kirby indicated that the new walking tour brochure has omitted the Lemon
 Block and recommended that in the next print should include it. Jackie will
 notify Tourism Rossland to correct this for the next print.
- c) Jackie attended the Heritage BC Conference in Burnaby in October. She pointed out at the Conference that small communities with large heritage stocks require more partnerships and suggested that the board may be able to help assist to liaise with larger industry partners.

6. Reports

- a) Chick's Memorial
 - Enough money has been donated in Chick's memorial to purchase a tree and a plaque for a City bench. It is hoped to have a memorial in the spring possibly when the tree is being planted.
- b) RDKB \$10,000 grant Tombstone Report
 Jackie provided copies to the members of all the tombstones that have been repaired in 2012 (by the City) and 2013 (by K2 Contracting) over 55 repair jobs.
 The final allocation of \$10,000 towards cemetery restoration from the East End Cemetery Function of the RDKB was allocated to tombstone repairs (\$8500) and vegetation control by the City (\$1500).
- c) Columbia Cemetery Database
 - Jackie expressed that she has no more sources to research as to the exact locations of people buried in the Columbia Cemetery. The project began over four years ago with over 300 unidentified sites (out of a total of nearly 1000), the number of "unknowns" is down to 125. Dave Nutini will be given the list for final printout to go on the City website for publication of the cemetery database. Jackie would like to add more commentary to the publication with a final hard copy version to be published next year.
- d) Heritage Home Inventory Project Next Steps
 Joanne Drystek is working on formatting the text and pictures for the Updated
 2013 Heritage Home Inventory. Jackie recommended that rather than publishing
 two copies, that the Heritage Commission prints 50 hardcopies and then at some
 point in the future try and integrate the inventory into the City website.
 Estimated cost without taxes is just over \$1500 and there is money in the budget.
 There is also an opportunity for revenue through sales. Jackie asked the Heritage
 Commission to review the entries in the 1983 Inventory, given the criteria of
 construction date and heritage characteristics.

Jackie Drysdale – Stated that there is an interest for Heritage Tourism, however it is not getting as much promotion through Tourism Rossland and the Rossland Chamber of Commerce.
