MEMBERS REPORTS (VERBAL)

Councillor Greene:

Councillor Greene reported that he attended a Design Review Panel meeting on February 16, 2017, noting that the Panel discussed the possibility of evolving the Panel as per suggested by downtown businesses. The subject will be discussed at the next Panel meeting, with the recommendations to be forwarded to Council in the near future.

Councillor McLellan:

Councillor McLellan reported the following:

- Attended the Smokettes tournament on February 25, noting that he discussed the arena operations with individuals in attendance;
- Attended the Seniors Age Friendly meeting on February 8;
- Attended a Regional District of Kootenay Boundary (RDKB) Sewer Committee meeting on February 15, noting that the Committee resolved to allocate money into the reserves for SCADA upgrades;
- The Regional sewer requisition for Rossland is projected to increase by approximately 2.5%;
- The RDKB East End Services Committee was provided with a presentation by Trail Mayor, Mike Martin, in regards to potential contaminated sites in the area;
 - The Trail and District Arts Council provided a presentation, noting that the society will not assume the Trail Arena operation until 2019;
 - The Kootenay Trails Society's budget request was approved; and,

- Various budgets were discussed, noting that both the Victims Assistance and 911 requisitions have decreased, and that Rossland has been approved for an additional \$7,500 for cemetery capitals expenses.
- Attended an RDKB Committee-Of-The-Whole meeting on February 16, noting that the Financial Feasibility Study Terms of Reference were approved;
- Will be attending the RDKB Board meeting at Mt. Baldy on February 21; and,
- Will be attending the WKBRH Board meeting on behalf of Mayor Moore on February 22.

It was suggested that staff investigate the implications of designation, and geographical scope of designation, of the contaminated site area discussed above.

Councillor Zwicker:

Councillor Zwicker reported the following:

- Attended a Sustainability Commission meeting, noting that the Commission will be pursuing Columbia Basin Trust grant funding;
 - The next Energy Crawl will be held on May 13;
 - There will be a Builders Workshop on March 8 from 7:30 a.m. until noon, which will be held to discuss the building of 'Green' homes;
 - The solar monitoring project at the Rossland Public Works yard is still underway;
 - Rossland Car Share is looking for more participants to ensure that the program continues to run; and,
 - The Food Security Task Force is working on organizing an event at the Fire Hall in regards to food security education, compost ideas, etc.

Councillor Morel reported that he attended a Lower Columbia Community Development Team Society meeting on February 16, noting that negotiations are commencing between the City of Trail and the Ministry of Environment in regards to the designation of potential contaminated sites.
