



TERMS OF USE AGREEMENT: The Terms of Use, as set out below, contains the terms and conditions which govern your use of the Recreation Department's online registration site. Carefully read the Terms of Use before proceeding.

By clicking the "I agree" button below to these terms and conditions, you acknowledge having read, understood and accepted the Terms of Use. If you do not agree to the Terms of use, you will not be able to register for recreation programs online. However, you may choose to use our alternate registration methods, including telephone or in-person registrations at the City of Rossland Recreation Department.

PRIVACY POLICY: Personal information submitted or collected through this Site will only be used for the purpose for which it was collected, except with the consent of the individual or as required by law in accordance with The Local Authority Freedom of Information and Protection of Privacy Act. Personal information shall be retained only as long as necessary for the fulfillment of those purposes collected. By agreeing to the Terms of Use Agreement, you are consenting to the collection of your personal information. If you do not wish to consent to the collection of your personal information then you will not be able to register for program. However, you may choose to use our alternate registration methods, including telephone or in person registrations at the Recreation Department.

The City of Rossland may monitor network traffic to identify unauthorized attempts to upload, delete or change information, or otherwise cause damage. The City records the Internet Protocol (IP) address of the computer that has contacted the Site, the date and time of the visit and the pages visited. We make no attempt to link these addresses with the identity or individuals visiting the Site unless an attempt to damage the Site has been detected or we are legally obligated to do so by law.

You should also be aware that there is a possibility that some personal information collected could be ordered to be disclosed to the United States Government pursuant to American anti-terrorism legislation, *The USA Patriot Act*. This may occur where the information collected is in the possession of an American company or a Canadian subsidiary or related corporation of an American parent company.

WAIVER: By Registering, you have agreed to the following:

RELEASE FROM RISKS: I understand that participating in some events may be potentially hazardous, and that I should not enter and participate in any such event unless I am medically able and properly skilled. In consideration of the acceptance of this registration, I assume full and complete responsibility for any injury or accident which may occur while I am traveling to or from the event, during the event, or while I am on the premises of the event. I also am aware of and assume all risks associated with participating in this event, including but not limited to falls, contact with other participants, effect of weather, traffic, and conditions of the road. I, for myself and my heirs and executors, hereby waive, release and forever discharge the event organizers, sponsors, promoters, the City of Rossland and each of their agents, representatives, successors and assigns, and all other persons associated with the event, for all liabilities, claims, actions, or damages that I may have against them arising out of or in any way connected with my participation in this event. I understand that this waiver includes any claims, whether caused by negligence, the action or inaction of any of the above parties, or otherwise.

REGISTRATION: You can register using the new online registration option and pay with credit card. You can also register for programs at the Recreation Department in person, at 1899 Columbia Ave, inside City Hall. The office is open Monday to Friday, 9:00-4:00pm and we accept cash, cheque, debit and credit cards. Payments must be made at the time of registration. We cannot hold spots from over the phone registrations.

REGISTER EARLY: Registering in advance allows us time to consider adding an extra class if the course is full, to ensure adequate supplies are available and to make staff / instructor changes if we need to expand the program. If everyone waits until the last minute to register for a program, it may cancel, resulting in disappointment for yourself and others.

REFUNDS: · No fee will be charged for persons withdrawing from a recreation program prior to the start of the program. Once a program has started, refunds will be issued only in the case of a medical issue.

CANCELLATION POLICY: All programs have a “drop dead date” 3 days before the start of the program. This date means unless the minimum numbers of participants are registered, the program will be cancelled. This allows for parents to find alternative childcare and allows Instructors adequate time to readjust their plans.

AGE POLICY: If the program indicates it’s for children ages 7-11, then your child must be at least 7 years old on the first day of the program. This helps us to ensure that the content and delivery of the program is age appropriate.

PHOTOGRAPHS & VIDEOS: The Recreation Department will be using pictures and videos of local folks and children, enjoying recreation in Rossland. We will attempt to obtain consent from individuals who are featured in the pictures and videos, but this may not always be possible. If you have any concerns about being represented in photos or videos taken by the Recreation Staff, please let us know.
